



Inter-institutional Study Abroad Agreement

between

BINUS University ("The Home Institution") and King's College London ("King's")

This Agreement is made in London by and between:

BINUS UNIVERSITY whose principal place of business is at Jl. K.H. Syahdan No. 9 Palmerah, Jakarta Barat 11480, Indonesia.

And

KING'S COLLEGE LONDON, UNIVERSITY OF LONDON whose principal place of business is at 57 Waterloo Road, London SE1 8WA, UK.

- 1. The Home Institution and King's hereby agree on the following terms and conditions for students from The Home Institution to study as Study Abroad (independent) students at King's ("Agreement") from the date of this Agreement.
- 2. The Home Institution ensure that the students participating in the Study Abroad at King's know their rights and obligations according to this Agreement.
- 3. The Home Institution's students who study abroad at King's continue to be regarded as fully matriculated of the home institution during the time of their overseas study and retain their eligibility for loans and other federal financial aid available to all regularly enrolled students in accordance with The Home Institution's regulations and policies for off-campus study with affiliated programmes.
- 4. Students from The Home Institution may enrol for the full year (September June), for the first semester (September December), or for the second semester (January June), and to the Summer School programme.
- King's will consider the admissions of all students registered at and nominated by The Home
 Institution, subject to acceptance of their qualifications and availability of places in their major
 subjects. King's reserves the right to make final judgements on the admissibility of each student
 nominated.
- 6. The Home Institution will screen their applicants for participating in the King's Study Abroad programme to ensure they meet the eligibility requirements advised by King's, including academic and language requirements. These requirements are published on the Study Abroad applications section of the King's website: www.kcl.ac.uk/studyabroad. To be accepted into the Summer School programme, applicant must met the entry requirements as listed here: http://www.kcl.ac.uk/study/summerschool/admission/admissions.aspx.

- 19. Students from The Home Institution are bound by all published King's academic, behavioral, and other programme regulations in addition to The Home Institution's behavioral guidelines. Students who violate regulations may be subject to expulsion from the King's programme. All such decisions will be made in direct consultation with administration from The Home Institution.
- 20. Each party hereto is solely responsible for its own negligence, acts or omissions.
- 21. King's and The Home Institution shall be independent contractors.
- 22. Any additional or contrary terms and conditions proposed by The Home Institution shall be binding upon King's only if agreed upon in writing.
- 23. This Agreement will come into effect upon signing, and shall be considered to be in force and valid for a period of 2 (two) years, for students enrolling from 1 September 2012 to 31 August 2014.
- 24. Either party may terminate this agreement on written notice to the other party by giving at least 6 (six) months advance notice of the desired date of termination. Said notice shall be deemed given if sent by facsimile or by registered mail or recognized overnight delivery service, postage prepaid address to the other party at the address given herein. Delivery will be deemed effective upon transmission by facsimile (with receipt acknowledgment) or 3 days after deposit with the postal authorities or overnight delivery service.
